GENERAL CONDITIONS FOR ABOVE POSTS :

- Vacancies are reserved for Disabled (Physically Challenged) Persons and the definition of Low Vision (LV), Orthopaedically Handicapped (OH) and Hearing Handicapped (HH) will be as per the 'Persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act, 1995 (1 of 1996)'. Further, only such persons would be considered who suffer from not less than 40% of the relevant disability.
- The above posts carry benefits such as CPF, Gratuity, Industrial DA, Conveyance Allowance, free medical facility, LTC/LLTC etc. as admissible & as per the rules of the company.
- For the post of Attendant-cum-Jr. Staff Assistant, applicants have to furnish a certificate regarding proficiency in MS Office package. Candidates not fulfilling the above requirements need not apply.
- All candidates found eligible for the above posts may have to appear for a Written Examination (Objective type) the date, time and place of which will be intimated later on. Candidates shortlisted on the basis of the Written Examination, will be called upon for Practical Test and / or Interview later on.
- The candidates employed in Govt. Department / PSU / Autonomous bodies must produce NOC at the time of Interview. In case, the candidate fails to produce the certificate, his / her candidature will not be considered.
- Attested / Self Attested Photocopies of all academic and professional qualifications, proof of Date of Birth (Matric / High School Certificate), Caste Certificate issued by a Revenue Officer not below the rank of Tehsildar, attested photograph should be attached along with the application. Applications not accompanied with attested copies of certificates and photograph will be rejected. All certificates should be either in Hindi or English only.

- Upper age limit is further relaxable by 5 years for SC/ST (PH) candidates and 3 years for OBC (PH) candidates.
- The OBC candidates who belong to "CREAMY LAYER" are not entitled for OBC concession and such candidates have to indicate their category as "General".
- For claiming the benefit admissible to PWDs under the Act, candidates are required to produce disability certificate issued by the Medical Board duly constituted by the State Govt./Central Govt. as per the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995. They have to satisfy the relaxed Physical Standard required for the posts. In case, the candidate fails to produce the certificate in the prescribed format issued by Competent Authority, his/her candidature will not be considered.
- Envelope containing the application should be clearly superscribed 'Application for the post of _____'
- Candidature of a candidate is liable to be rejected at any stage of the recruitment process or after recruitment or joining, if any information provided by the candidate is found to be false / not in conformity with the eligibility criteria mentioned in the advertisement. Bhilai Steel Plant reserves the right to reject the applications and no communication in this regard will be made with the applicants.
- Bringing influence at any stage of the selection process will disqualify the candidate.
