Filling up of the post of One Superintendent in the office of the Adjudicating Authority, PMLA, New Delhi on deputation basis

One post of Superintendent in the pay band of PB-2 Rs. 9300-34800 + Grade Pay 4800 (Gazetted, General Central Service) is to be filled up on deputation basis only in Adjudicating Authority (PMLA) Department of Revenue, New Delhi: The eligibility conditions for deputation are as follows : Officers under the Central Government:

(a) (i) holding analogous post on regular basis in the parent cadre/department; **or**

(ii) with three years' service in the grade rendered after appointment thereto on a regular basis in the grade pay of Rs. 4600/- in PB-2 or equivalent in the parent cadre/department;

or

(iii) with seven years' service in the grade rendered after appointment thereto on a regular basis in the Grade pay of Rs. 4200/- or equivalent in the parent cadre/department;

and

(b) possessing the following educational qualification and experience :

(i) Bachelor's degree from a recognized University or equivalent.

(ii) Three years' experience of handling Administration, Accounts/Budget, etc.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the

same or some other organization/department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of application.)

The period of deputation would ordinarily be for a period of one year which is extendable on year to year basis depending on satisfactory performance. In the event of misconduct or unsatisfactory performance, the incumbent may be repatriated before completing his/her tenure. Qualifications and eligibility criteria are relaxable at the discretion of the Authority in deserving cases.

The deputation will be governed by the terms & conditions as contained in the DOP & T's O.M. No. 2/29/91-Estt (Pay II) dated 05.01.94 as amended from time to time.

Attested photocopies of ACRs of the applicants for the last 5 years along with Vigilance Clearance may also be sent along with his/her applications.

The applicants who volunteer for the post will not be permitted to withdraw their names at a later date, only such applications which are duly forwarded by the office and accompanied with ACRs and Vigilance Clearance will be considered.
