DECLARATION OF FINAL RESULT FOR THE POST OF ASSISTANT SUB-INSPECTORS IN CENTRAL INDUSTRIAL SECURITY FORCE EXAMINATION, 2010

The Staff Selection Commission conducted Assistant Sub-Inspectors in Central Industrial Security Force Examination, 2010 on 29.08.2010. Total 18309 candidates were declared qualified to be called for PET/Medical on the basis of cut off fixed on Paper I. Total 3050 candidates cleared PET and Medical and were called for Interview.

The result has been processed on the basis of the aggregate marks obtained by the candidate in the written examination and interview / personality test.

- 5. Resolution of Tie cases: Resolution of tie cases, where more than one candidate secured equal aggregate marks, was done by applying the following criteria one after another:-
- (i) By referring to the total marks in the written examination;
- (ii) By referring to the marks in Paper I where the first cut off is given i.e. a candidate having more marks in this paper is given preference.
- (iii) By referring to the date of birth of the candidate, i.e. the candidate older in age gets preference;
- (iv) By referring to the alphabetical order of names of the candidate i.e., a candidate whose names begins with the alphabet which comes first in alphabetical order gets preference.
- 6. The candidature of 136 candidates have been withheld, pending clarification from respective RDs/DDs. The roll numbers of 136 candidates (111 Male and 25 Female) whose results have been kept as withheld are as given below.

The above said Lists are purely provisional and subject to the recommended candidates fulfilling all the eligibility conditions prescribed for the respective post in the Notice of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. The candidature of the candidates are liable to be cancelled by respective Regional Directors in case candidates found not fulfilling the eligibility conditions or for any other genuine reasons.

8. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as per Government Policy, the category status is indicated against their Roll Numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their Roll Numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/ she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Office of the Commission in all such cases where they do not belong to the category shown against their Roll Numbers. Similarly, candidates whose result has been withheld are also advised to contact the concerned regional office of the Commission to prove their category status/remedy document deficiencies.
