1. Age limit between 18 years to 30 years as on closing date for application relaxable for SC, ST, OBC only against, reserved quota and for in-Service candidates of ICAR as per rules.

2. Last date of receipt of Application **within 30 days** of appearing of Adv. in Newspaper.

#### General Instructions:

1. Application received after due date shall not be entertained.
2. The post is temporary, non-government and non-pensionable under ICAR will be governed by New Pension Scheme introduced by Govt. of India w.e.f. 1-1-2004 mutatis mutandis and as amended form time to time.
3. Interested candidates must apply in the following format of application and enclosed attested copies of necessary documents.  
Name (In Hindi & English), Date of Birth, Caste, Educational Qualification, Subjects, Year of passing the exams, Marks obtained, Permanent and Present Address, Experience (if any), No objection certificate of the present employer (if any), Marital status. Other qualification, and Signature and one passport size recent photograph duly attested should be pasted on the right top corner of the application.
4. Incomplete application / form shall not be entertained.
5. Candidates already in service will have to send their application through proper channel and will have to submit no objection certificate at the time of interview.
6. The post is temporary but likely to continue in future. Present posting place is Mukteshwar (Nainital) but can be transferred anywhere in India.
7. The envelope containing the application form should be superscribed "Application for the post of Technical Assistant T-3 (Lab)" should be clearly indicated on the top of the envelope.
8. Application form complete in all respects along with application fee of Rs. 100/- (Rupees one Hundred) in the form of D.D. in favour of I.C.A.R. Unit PD FMD payable at SBI Mukteshwar drawn at SBI should reach in the office of Project Directorate on FMD, Mukteshwar- Kumaon, Distt. Nainital (Uttarakhand)-263138 **within 30 days** of the appearing of advertisement in the newspaper by post/by hand. (No fee for SC/ST candidates and they will be paid 2nd Class Train/Bus fair by the shortest route for interview on submission of tickets). Women candidates are also exempted from payment of fee.
9. Only those candidates shall be called for the interview whose application shall be recommended by the screening committee constituted by this Project Directorate.
10. Project Director, PD on FMD reserves all the rights to reject any application at any time without assigning any reasons.
11. No age relaxation is allowed to SC/ST/OBC candidates against un-reserved posts even if they qualify for such posts where only UR vacancies exist, they will be rejected on age ground if they do not fulfill the UR age criteria. In the same way if SC/ST/OBC candidates qualify in the UR merit list but they do not fulfill the UR age criteria, they will be adjusted against their respective quota vacancies, if available.
