Recruitment notice for the Post of Firemen

Applications as per specimen given are invited from eligible **Male** candidates for the post of Firemen to reach Commanding Officer, 5 Mtn Div Ord Unit, Pin-909005. C/o 99 APO by registered post **within 21 days** from the date of publication of the advertisement. The First' date of publication of this advertisement in **Employment News** will be taken into account for calculation of **21 days**. Note ()** : (a) The Physically Handicapped (Hearing Impaired only). Ex-serviceman & sports candidates selected for appointment will be placed against the category to which he belongs. If the applicant selected belongs to ST/OBC/Gen/SC category he will be placed in that respective category.

(b) Out of 12 (Twelve) vacancies, the following vacancies are reserved for the categories mentioned against each:

(i) Physically Handicapped (Hearing Impaired only)	01 (one)
(ii) Ex-serviceman	01 (One)
(iii) Sports	01 (One)
(iv) OBC	02 (Two)
(v) Scheduled Tribe	01 (one)
(vi) Scheduled Caste	02 (Two)

2. **Calculation of Age** : Last date of receipt of the applications will be taken into for calculation of age.

3. **Age for Physically Handicapped** : Age for Physically Handicapped categories are to taken as follow : (a) Gen-18 to 35 years (b) ST-18 to 40 years (c) SC-18 to 40 years (d) OBC-18 to 38 years.

4. **Age for Ex-servicemen** : Service rendered in Army/Air Force/Navy shall be allowed to be deducted from actual age of the individual and if the resultant age does not exceed maximum age prescribed for the post by more than three years shall be deemed to satisfy the condition regarding age limit.

5. **Physical Standards Required**: Candidates are required to be physically fit to perform strenuous duties of firemen and should meet the following physical standards.

- (a) Height without shoes - 165 cms (concession of 2.5 cms for ST)
 (b) Chest (un-expanded) - 81.5 cms (Chest on expanded - 85 cms)
 (c) Weight - 50 Kgs (Minimum)

(A certificate of physical standards from registered medical practitioner be submitted along with the application).

6. The candidates are required to pass following physical test at the time of recruitment:-

- (a) Running - 1.5 Km run in 06 minutes.
 (b) Firemen Lift - Carrying a man of 63.5 kg to a distance of 183 Mtrs within 96 seconds.
 (c) Long Jump - Clearing 2.7 Mtrs wide ditch landing on both feet.
 (d) Vertical Rope - Climbing 3.0 Mtrs vertical rope using hands and feet.

7. **Place of work** - 5 Mtn Div Ord Unit, C/o 99 APO with All India Service Liability.

8. Written test will be conducted with a maximum of 40 marks and interview for 20 marks.

9. Physical tests/written test/interview for all categories will be intimated in **Call Letters**.

10. Application will be accepted only through Registered Post. The application should be

addressed to **Commanding Officer, 5 Mtn Div Ord Unit, C/o 99 APO, Pin-909005**. No application will be accepted **By Hand**. Unit will not be responsible for loss of application in transit and for postal delay. No Travelling allowances will be paid for the test/interview. The candidates themselves will make arrangement for boarding and lodging. No application will be entertained after the due date. While forwarding the application, the envelope should be clearly marked **"Application for the post of Firemen/Ex-Servicemen/Sports Persons/Physically Handicapped/ST/OBC/SC/Gen: (Delete whichever is not applicable)**.

11. One 12x18 cm self-addressed envelope affixed with Rs.25/- (Twenty five) postage stamp should be attached along with the application form. **Do not forward Original Certificate** with the application. The attested copies of following documents must be attached with application form : (a) Birth Certificate (b) Medical Certificate from a registered medical practitioner for physical standards. (c) Caste certificate (d) Education certificate (e) Photocopy of discharge certificate for Ex-servicemen. (f) Disability certificate for Physically Handicapped. (g) Domicile certificate.

12. Candidates, whose application are found to be correct and who are eligible for test and interview will be called through **Call Letters**. The names will also be displayed on a Notice Board at the main Gate of **5 Mtn Div Ord Unit, C/o 99 APO, Pin-909005** for five continuous days prior to the date of interview/tests.

13. Unit will not be responsible to pay any compensation in case of injury/death of a candidate during and after physical tests and also reserves the right of rescheduling the date of test/interview due to Strike/Bandh/Curfew/Protests.

14. **Rejection:** The following acts/omission would render a candidate/application disqualified (a) Furnishing of false, inaccurate or tampered information. (b) Obtaining support for his candidature through unfair means. (c) Impersonation by any person. (d) Submitting fabricated documents (e) Making statements, which are incorrect or false or suppressing material information. (f) Resorting to any other irregular or improper means, in connection with his candidature for the selection. (g) Improper filling of applications. (h) More than one application submitted by the candidate (i) Any other reason as observed by the Board of Officers.

15. Selected candidates will be given appointment letter by concerned authorities subject to verification of character and antecedents from concerned District Magistrate and medical fitness from medical authorities.
