Subject: Filling up the post of Chairman (part time) and Members (part time) in Delhi Urban Art Commission (DUAC).

1. The Ministry of Urban Development is in the process of selecting suitable persons for appointment as Chairman (part time), and Members (part time) in the Delhi Urban Art Commission (DUAC), which is a statutory body under this Ministry. As per Section 4 of DUAC Act 1973, the Commission consists of a Chairman and such number of other members, being not less than two and not more than four as the Central Government may appoint from amongst persons, who, in the opinion of the Central Government, have sensibility and interest in the plastic and visual arts and urban development, or possess special knowledge or practical experience in respect of architecture or art.

2. Guidelines prescribed for appointment to the said posts are given below:

Interested candidates who fulfill the above eligibility conditions may send their applications giving complete details including name, address, educational and professional qualifications, date of birth, experience in the field of urban environment, art, culture, heritage and architecture and other relevant information to Director (DD), Ministry of Urban Development, "C" Wing, Nirman Bhawan, New Delhi-110 011, for inclusion in the Panel proposed to be drawn up by this Ministry for the posts of Chairman (part time) and Members (part time) of DUAC. The last date for receipt of applications in the Ministry is 30th April, 2011.
