# ITBP Eligibility and other conditions for Filling up of 01 (One) post of Sub-Inspector (Hindi Translator) in ITBP on deputation

Applications are invited from eligible candidates for filling up of 01 post of Sub Inspector (Hindi Translator) in the Pay Band-2 Rs. 9300-34,800 + Grade Pay Rs. 4200/- on deputation in ITB Police. Person selected for deputation can be posted in any part of India or outside India.

#### Eligibility for deputation/absorption : For the post of Sub-Inspector (Hindi Translator) in ITBP.

Officers from Central Government Departments or Central Police Organisations holding analogous post on regular basis in the parent cadre or Department or with six years' regular service in the Pay Band-1, Rs. 5200-20200 and Grade Pay of Rs. 2800 and possessing qualification as under :

(i) Graduate from a recognized university with Hindi as one of the main subject and English as an elective subject and working knowledge of computer application.

(ii) Two years' working knowledge of translation from Hindi to English and English to Hindi and Computer application.

**Note-1**: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in same or some other organisation or department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall not be exceeding 52 years as on the closing date of receipt of application.

**Note-2 :** - For purpose of appointment on deputation/absorption basis, the service rendered on a regular basis by an officer prior to the 1st January 2006, the date from which the revised pay structure based on the 6th Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Commission.

#### For ex-servicemen deputation & re-employment.

The Armed Forces personnel due to retire or who are to be transferred to reserve within a period of one year and having requisite experience and qualifications prescribed for deputationists shall also be considered. Such persons would be given deputation terms upto the date of on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

# Medical Standards :

(b) The candidates must not have knock-knee, flat foot/Varicose Vein or squint in eyes and they should possess high colour vision. They must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of the duties.
