**1. Eligibility : A) Educational qualification Essential:**

Diploma in Textile Technology or pass SSC or its equivalent examination from a recognized board with Khadi Karya Karta Course / Khadi Katai Visharad Course/ Amber Karya Karta Course/ Bunai Karya Karta Course Certificate Course in textile by Khadi & V.I. Commission / State / Central Government.

Desirable : Degree in Textile Technology

**2. Age** : Between 18 to 27 years.

Relaxation : (SC : By 5 years) (OBC : By 3 years) (PH : By 10 years)

Ex-Serviceman : By 3 years in addition to usual period of service in the defence forces subject to maximum age of 50 years.

Govt. Employees : 35 years

**3. Selection Procedure:**

(a) Selection will be on the basis of performance in personal interview.

(b) The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview.

(c) Where the number of applications received in response to the advertisement is large and it will not be convenient or possible for the KVIC to interview all the candidates, the KVIC at its discretion may restrict the number of candidates to a reasonable limit by any one or more of the following method:

i On the basis of their qualifications higher than the minimum prescribed in the advertisement, or

ii On the basis of the experience in the relevant field, or

iii By holding a screening test.

The candidate should therefore, mention all the qualifications and experience in the relevant field over and above the minimum qualifications and should attach attested /self certified copies of the certificate in support thereof.

**4. Appointment :** The candidates selected will be posted anywhere in India.

**5. How to apply :** Applications format should be typed neatly in Hindi or English in prescribed format. Application and copies of the required certificates must be sent by ordinary post only in a cover super scribed "APPLICATION FOR THE POST OF SUPERVISOR-III (KHADI)".
