It is proposed to fill Four (04) posts of Senior Stores Superintendent in the pay scale of Rs. 5500-175-9000 (pre-revised) in the Armed Forces Medical Stores Depot, Lucknow, Mumbai and O/o DGAFMS by **Deputation or re-employment of Ex-servicemen**. Accordingly applications from suitable candidates through their respective Departments are invited to prepare a panel of candidates for filling up the abovementioned posts. The eligibility conditions for filling up the above posts are as under:

(a) (i) Holding analogous posts on regular basis in the parent cadre or department.

OR

(ii) With three years service in the grade rendered after appointment thereto on regular basis in the pre-revised scale of pay of Rs. 5000-8000 or equivalent in the parent cadre or department.

and

(b) Possessing the following educational qualifications and experience:

Essential:

(i) Diploma in Material Management or any diploma having Material Management as a subject or Diploma in Pharmacy from a recognized University or Institution or equivalent.

(ii) Three years experience as Supervisor of Stores preferably in Medical Stores in Hospitals or Dispensaries or Drug Manufacturers of repute.

Desirable:

Experience in Computer or Information Technology.

For Ex-servicemen:

Note 1: The Armed Forces Personnel of the rank of Junior Commissioned Officer due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation terms upto the date on which they are due for release from the Armed Forces; thereafter they may be continued or re-employment. (Re-employment upto the age of Superannuation with reference to civil posts.)

Note 2: The suitability of the incumbent in the feeder grade (Rs.5000-8000) with the requisite service shall be considered by the competent authority. In case the individual is considered fit he shall be deemed to have been promoted to the higher grade of Rs. 5500-9000. In case he is not considered fit his case will be reviewed every year. Till such time, he will continue to hold the post in the lower grade.

Note 3: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion. Periods of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceed 56 years as on the closing date of the receipt of applications.

(a) Name of Post : Senior Stores Superintendent

(b) Number of Vacancies (tentative) : Four

(c) Classification: General Central Services, Group 'B', Non- Gazetted.

(d) Scale of Pay : Rs. 5500-175-9000 (pre-revised).

(e) Duration of deputation: Ordinarily not exceeding three years.

(f) Place of posting (tentative) : Delhi, Mumbai and Lucknow

3. The appointment shall be governed by Department of Personnel & Training OM No.2/29/91 Estt (Pay-I) dated 05 Jan. 1994.

4. To whom the Application or Documents need to be sent:

Application (in duplicate) in the enclosed proforma along with duly attested copies of the complete and up-to-date CR dossiers by the competent authority in his/her office/department in respect of the Officers who could be spared in the event of selection may be sent to the **Director AFMS (Plg), Office of the DGAFMS, Ministry of Defence, M Block, New Delhi-110001 within 60 days**. Applications received after the last date or without the CR dossier or otherwise found incomplete will not be entertained.

5. As regards qualification asked for vide para 1 (a) & (b) above is concerned, a certificate from the competent authority will be attached giving the details of experience.

6. It may be noted that candidates who once apply for the post and selected will not be allowed to withdraw his/her candidature or revert to their parent cadre without completing the period of deputation.
