Applications are invited from eligible candidates for filling up, on Deputation basis, one vacancy of the post of Chairman, Commission for Scientific and Technical Terminology, New Delhi, an Attached Office of the Ministry of Human Resource Development, Government of India in Pay Band PB-4 (Rs. 37,400-67,000) with Grade Pay 10,000/- from persons possessing qualifications and experience mentioned below, in the prescribed preformed published in the Employment News/Rozgar Samachar. Pay Scale: Pay Band PB-4 Rs.37,400-67,000/- plus Grade Pay of Rs.10,000/-

Mode of Recruitment : Deputation (including short-term contract)

**Period of Deputation :** Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Govt. shall ordinarily not exceed five years.

Age limit : The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of the receipt of applications. The age of the applicants would be reckoned as on the closing date for receipt of applications as per the advertisement for the post published in the Employment News/Rozgar Samachar.

## Field of Selection : Deputation (including short-term contract)

Officers under the Central/State Governments/Union Territories/Universities/Recognized Research Institutions/Public Sector Undertakings or Semi-Government/Statutory or Autonomous Organizations :

(a) (i) holding analogous post on regular basis in the parent cadre or department; or

(ii) with two years' service in the grade rendered after appointment thereto on a regular basis in post in PB-4 in the scale of pay of Rs. 37400-67000/- with grade pay of Rs. 8900/- or equivalent in the parent cadre or department; **or** 

(iii) with three years' service in the grade rendered after appointment thereto on a regular basis in post in PB-4 in the scale of pay of Rs. 37400-67000/- with grade pay of Rs. 8700/- or equivalent in the parent cadre/department; **and** 

(b) Possessing the following educational qualifications and experience:-

**Qualifications and Experience Essential :** (i) Doctorate degree in any branch of Science or Arts or Commerce or Agriculture or Engineering or Medicine from a recognized University or Institute;

(ii) 18 years experience in academic or teaching or research work in a recognized Institution including at least three years administrative experience; or
