Last date for receipt of applications is 21 May 2011.
2. Relaxation in age is admissible as per Govt. of India Rules for the categories belonging to SC/ST/OBC.
3. All posts are temporary but likely to be permanent with probation period of two years.
4. Candidates after selection will be subject to "All India Service Liability Rules", "Field Service Liability Rules" and "Army Act 1950".
5. Selection will be subject to Medical Fitness and Verification of Character and antecedents from Civil authorities.
6. No Traveling Allowance will be admissible for test/ interview.
7. Date & Time of Test/Interview will be intimated by post separately to the eligible candidates whose application is found in order.
8. Candidates will bring original certificates in support of age, qualification, experience, caste and registration card of Employment Exchange etc on the date of test/ interview.
