The departmental officers in the feeder category or feeder grade to the post in feeder category, who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation basis. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not to exceed three years.
