SCALE OF PAY : Revised Pay Band: Rs.67000-79000 (HAG) (with annual increment @ 3%) plus NPA, as applicable, for Medical personnel.

METHOD OF RECRUITMENT : Direct Recruitment through a Search-Cum-Selection committee.

AGE : Preferably below 52 Years.

RELAXATION IN UPPER AGE LIMIT : The upper age limit shall be further relaxed upto 5 years for departmental candidates. The upper age limit is also relaxable upto 5 years in case of candidates otherwise exceptionally well qualified.

QUALIFICATIONS : Medical: Essential : (i) PG Medical degree in the field of Microbiology/Bacteriology/ Serology/ Virology/ Hematology or allied biological sciences. OR (ii) Ph.D in any of the above related fields.

NON-MEDICAL : Essential : (i) M.Sc in Microbiology/Bacteriology/Physiology/Bio-Chemistry or allied biological sciences. (ii) Ph.D in any of the above related fields.

EXPERIENCE : (i) 20 years standing in the profession (ii) Experience in research, training, manufacturing and quality control of biologicals viz. vaccines, blood products and other biological products for at least 15 years. (iii) Extensive administrative experience.

TENURE : Appointment shall be for a tenure of 5(Five) years-not extending beyond the age of 60 years. The tenure may be extended for a further term upto the age of 62 years or terminated on 3 months notice or pay, if considered appropriate.

The person selected for this post would be prohibited from seeking/applying for any other employment for a period of 3 years.
