Filling up of one post of Additional Industrial Adviser (Electronics) on Deputation (Including Short-Term Contract)/Promotion Basis in office of the Development Commissioner, Micro, Small and Medium Enterprises Development Organisation.

1. Applications are invited for filling up of one post of Additional Industrial Adviser (Electronics) Group 'A' Gazetted, Scale of pay Rs. 16400-450-20000 in the Micro, Small and Medium Enterprises Development Organisation under the Ministry of Micro, Small and Medium Enterprises. The post is proposed to be filled by appointment of suitable Central Govt. Officers on deputation plus promotion basis.

2. The pay of the officer selected for the post on deputation will be regulated in accordance with the Deptt. of Personnel & Training O.M. No. 2/12/87-Estt. (Pay-II) dated 29.4.88 as amended from time to time.

3. It is requested that applications (in duplicate) in the prescribed proforma (given below) duly signed by the applicant and endorsed by the employer along with the complete and up-to-date Confidential Reports of last five years of the officers who fulfill the eligibility conditions and possess the essential/desirable qualifications/experience and who can be spared in the event of their selection may be sent to Deputy Director (Admn.), Office of the Development Commissioner (Micro, Small and Medium Enterprises), Room No. 707, Nirman Bhavan, New Delhi - 110011 within 60 days from the date of its publication in the Employment News. In case original ACR Dossiers cannot be sent, photocopies of the ACRs for the last five years, duly attested by an officer not below the rank of Under Secretary may please be forwarded. Applications received directly or without signature of the applicant and endorsement by the employer or after the last date or without the Confidential Reports or otherwise found incomplete will not be considered. While forwarding the applications it may be verified and certified that the particulars furnished by the officer are correct and that no disciplinary case is pending or contemplated against the officer and he/she has not been awarded any major/minor penalty during the last 10 years. - 2. Status :** Group 'A' Gazetted.
- 3. Scale of pay :** Pre-revised scale of pay of Rs. 14,300-18,300/- (Revised Rs. 37,400-67,000, PB-4, Grade Pay Rs. 8,700/-).
- 4. Eligibility :** Officers under the Central Government or State Governments or Union Territories or Universities or Recognised Research Institutions or Public Sector Undertakings or Semi Government or Autonomous or Statutory Organisation :
 - (a) (i) Holding analogous post on regular basis in the parent cadre or department; or (ii) With five years' service in the grade rendered after appointment thereto on a regular basis in the pre-revised scale of pay of Rs. 12,000-16,500/- (Revised Rs. 15,600-39,100, PB-3, Grade Pay Rs. 7,600/-) or equivalent in the parent cadre or department; and
 - (b) Possessing the following educational qualifications and experience :

Essential:

- Degree in Electronics or Communication Engineering or in Electrical Engineering with specialization in Electronics of a recognized University or equivalent;
- Twelve years' experience in a managerial technical position in a technical organization or in an industrial concern in development and production of electrical and electronics components and equipments;
- Should have knowledge in the latest techniques of production and use of modern machinery and equipment as applied to electrical and electronics industries.

Desirable:

- Master of Engineering or Master of Technology in Electronics or Telecommunication Engineering or Electrical Engineering with specialization in Electronics of a recognized University or equivalent;
- Experience in advising or developing industries in general and small scale industries in particular. II. The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

5. Age limit : The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding fifty-six years as on the closing date of receipt of applications.

6. Duties attached to the post : 1. To advise in formulation of policies for the promotion and development of small scale sector, viz. policy for reservation/de-reservation, technology upgradation programmes, quality management systems, energy conservation, pollution control, Government purchase programmes, raw material assistance and marketing supports, etc.

2. Planning and executing work - related to Entrepreneurs Development Programmes, Vendor Development Programmes, Sub-contracting Exchanges etc. through SIDO's outfits.

3. Planning and creating technical documents and data base to SSI entrepreneurs, viz. Project Profiles, Industry Studies, Cluster Studies, Sources of Supplies of various inputs for SSI sector etc.

4. Planning and implementation of Ozone Depleting Substance (ODS) phase out programme as per the Montreal Protocol for SSI sector in association with Ministry of Environment and Forest.

7. Period of deputation : Period of deputation (including short-term contract/including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed five years.
