Recruitment Notice for the post of Fireman

1. Applications as per specimen are invited from eligible Indian Nationals, **Male** candidates for the post of Fireman to reach **Commanding Officer, 10 Inf Div Ord Unit, Pin-909010, C/O 56 APO** by registered post **within 21 days** (28 days in case of candidates belonging to Andaman & Nicobar Islands and Lakshadweep) from the date of publication of this advertisement. The first date of publication of this advertisement in Employment News will be taken into account for calculation of 21/28 days respectively. The scale of pay, number of vacancies, educational qualifications and other requirements are as under:-

2. **Calculation of age.** Last date of receipt of the applications will be taken for calculation of age.
3. Out of 08 vacancies 02 vacancies are horizontally reserved for **Ex-Serviceman**.
4. **Age of Ex-Serviceman.** Service rendered in Army/Air Force/Navy shall be allowed to be deducted from actual age of indl and if the resultant age does not exceed maximum age prescribed for the post by more than three years, he shall be deemed to satisfy condition regarding age limit.
5. **Age limit for J&K State.** Relaxation of upper age limit for recruitment to Gp 'C and 'D' post is admissible to residents of J&K state and provision for relaxation in upper age limit is valid upto 31 Dec 2011.
6. **Physical Standards Required.** Candidates are required to be physically fit to perform strenuous duties of fireman and should pass the following tests :-
 (a) Height without shoes - 165cms (concession of 2.5cm for ST)
 (b) Chest (un-expanded)- 81.5 Cms (Chest on expansion-85 cms)
 (c) Weight - 50 Kgs (Minimum)
 (A certificate of physical standard from a Registered Medical Practitioner be submitted along with the application)
7. The candidates are required to pass following tests at the time of recruitment:-
 (a) **Fireman Lift.** Carrying a man of 63.5 Kg to a distance of 183 Mtrs within 96 seconds.
 (b) **Long Jump.** Clearing 2.7 Mtrs wide ditch landing on both feet.
 (c) **Vertical Rope.** Climbing 3.0 Mtrs vertical rope using hands and feet.
 (d) **Running.** 1.5 Km run in 06 minutes.
8. Written test will be conducted with a maximum of 40 Marks and interview for 20 marks.
9. **Applications will be accepted only through Registered Post. The application should be addressed to Commanding Officer, 10 Inf Div Ord Unit, Pin-909010, C/O 56 APO. No application will be accepted By Hand.**
10. One 12 X 18 cms self-addressed envelope affixed with Rs. 25/- postage stamp should be attached along with the application form. Don't Forward Original Certificates with the application. The attested copies of following documents must be attached with application form :-
 (a) Latest medical fitness Certificate issued by approved Central/State Govt Hospital giving measurements of height, chest and weight.
 (b) Caste certificate in cast of ST/OBC/SC.
 (c) Matriculation certificate age proof along with mark sheet.
 (d) Domicile certificate for candidates belonging to J&K State.
 (e) Discharge certificate for Ex-Serviceman duly attested by 'Gazetted Offrs.
 (f) Character certificate issued after 01-01-2011 from police authority or school/collage where the candidate has studied.
 (g) Certificate proof of Residence.
 (h) One additional attested photograph.
11. Candidates whose applications are found to be correct and who are eligible for test and interview will be called through **Call Letters**. The names will also be displayed on a Notice Board at the Main Gate of 10 Inf Div Ord Unit, C/O 56 APO for five continuous days prior to the date of interview/tests.
12. 10 Inf Div Ord Unit will not be responsible to pay any compensation in case of injury/death of a candidate during and after physical tests.
13. **Rejection.** The following acts/omissions would render a candidate/application disqualified :-
 (a) Furnishing of false, inaccurate or tampered information.
 (b) Obtaining support for his candidature through unfair means.
 (c) Impersonation by any person.
 (d) Submitting fabricated documents.
 (e) Making statements, which are incorrect or false or suppressing material information.
 (f) Resorting to any other irregular or improper means in connection with his candidature for selection.
 (g) Improper filling of applications.
 (h) More than one application submitted by the applicant.
 (i) Any other reason as observed by the board of officer.
14. No TA/DA will be admissible for attending test/interview.
15. Selected candidates will be given appointment letter by the concerned authorities subject to verification of character and antecedents from concerned District Magistrates and medical fitness from medical authorities.
16. Post is permanent, subject to individual completing two years probation successfully.
