1. <u>Vacancies</u> : Trade wise and category wise details of vacancies advertised are as follows :-

- Note: 1. 10% of vacancies in the post are reserved for Ex-Servicemen, which may later be filled up by fresh candidates, if suitable Ex-Servicemen do not turn-up.
 - 2. Number of vacancies may increase or decrease depending upon the position at the time of final selection without any notice.

2. Pay Scale and Other Allowances :

3. <u>Other Allowances:</u>

The post will carry Dearness Allowance, Ration Money, Washing Allowance, Free Uniform, Free accommodation or HRA, Transport Allowance, Free Leave Pass and any other allowance as admissible in the Force from time to time under the Rules/Instructions.

They will be covered under new restructured Contributory Pension Scheme.

4. <u>Eligibility Conditions</u> : The candidate must fulfill all eligibility conditions on the closing date of receipt of applications i.e. 15-06-2011.

A) <u>Age</u>

(i) 18 to 23 years (Cut-off date for age will be **15-06-2011**)

Children means (a) son (including adopted son); or dependent family members mean

(a) spouse: or (b) children or (c) brother in case of unmarried Govt. servant who was wholly dependent on the Govt. Servant at the time of his killing in the riots. Children and dependent family members of those killed in the riots (1984 riots and 2002 communal riots of Gujarat) will produce a certificate from the concerned District Collector wherein the victim was killed. SC / ST/ OBC relaxation, as per Govt. instructions, which will be in addition to this relaxation.

(d) One time age relaxation of 3 years in upper age limit will be given to the trained ITVs of SSB for recruitment in SSB as Constables as a special case, subject to the fulfillment of other prescribed eligibility conditions. This relaxation in upper age limit will be in addition to the existing relaxation in age limit for SC/ST/OBC category candidates, Candidates must produce supporting documents in support of their claim.

(e) Ex-servicemen who have put in not less than six months continuous service in the Armed Forces shall be allowed to deduct the period of such service from his actual age and if the resultant age does not exceed the prescribed maximum age by more than three years, he shall be deemed to satisfy the condition regarding age limit. <u>The eligibility</u> conditions for Ex-servicemen are as under:-

- V. Education :- Total relaxation in civil education but Army Education Should be equivalent to Matric.

(B) Educational & Other Qualifications for all posts:

1) Matriculation or equivalent form a recognized Board or Institute.

- 2) (i) Two years work experience in respective trade; **OR**
- (ii) One year certificate course from a recognized Industrial Training Institute or

Vocational Institute with at least one year experience in the Trade ; OR

(iii) Two years Diploma from recognized Industrial Training Institute in the trade or similar trade.

3) Must qualify trade test.

<u>Note:</u> Multi-skilled candidates will be given preference except for the post of CT(Blacksmith) and CT(Painter).

6. <u>Medical Standards:</u>

(a) <u>Vision</u>: Minimum distant vision should be 6/6 and 6/9 of both eyes without correction, i.e. without wearing glasses.

(b) The candidates must not have knock knee, flat foot, varicose vein or squint in eyes and they should possess high colour vision. They must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of duties. They should conform to the medical standards prescribed by the Force and should be declared fit by a board of Medical Officers of SSB.

9. <u>Selection Process :</u>

The eligible candidates shall be issued Admit Cards to appear in recruitment tests. The date and place of recruitment test will be indicated in the Admit Card. The Candidates will have to undergo the following documentation test and other tests:-

(i) **Documentation :**

The candidates who report at the designated recruitment centre on the given date and time will be first summoned to submit their call letter and other documents in original for verification of age and educational qualifications etc. Original documents will be returned on the spot after verification. Candidates should bring attested photocopies of documents as mentioned above.

(ii) **Physical Measurement (PST) :**

Candidates who are found eligible on screening of applications will be screened first medically as per para (5) under heading 'Physical Standard' mentioned above.

(iii) <u>Physical Efficiency Test (PET)</u>: The candidates who are found fit in above Physical Measurements, will be required to pass Physical Efficiency Test consisting of following events which is qualifying in nature:-

- **Note**: 1. Those who do not qualify the above Physical Efficiency Tests will get eliminated from the process and will not be allowed to appear in any further test.
 - 2. No physical efficiency test will be held for Ex-Servicemen. However, Ex-Servicemen will be required to pass the requisite written examination, trade test and medical examination.

(iv) <u>Written test (25 Marks)</u>: The candidates who qualify in the Physical Efficiency Test will be required to appear in a written test which will consist of questions of General Awareness/ General Knowledge, Knowledge of Elementary Mathematics. The questions will be objective type with multiple options and can be answered either in Hindi or English. The candidate must qualify the Written Test.

(v) <u>Practical /Trade Test (75 Marks)</u>:Candidates who qualify the Written Test will be put through Trade Test as per requirement of the job concerned. Candidates will have to pass the Trade Test.

(vi) <u>Medical Test</u>: Short listed candidates will be medically examined after the trade test to assess their physical and medical fitness as prescribed in the eligibility conditions. Those who fail in the Medical examination will not be considered for the post.

10. Appeal against the findings of Medical Examination

If a candidate is declared unfit in the detailed medical examination, the grounds for rejection will be communicated to him by the Chairman. The rejected candidates will obtain Form 4, 5 & 6 from the Chairman concerned, if not satisfied with the findings of the Medical Officer, to prefer an appeal for Review-medical examination to **Inspector General (Pers.)**.

<u>SSB Force HQ, R.K. Puram, New Delhi,</u> within 15 days from the date of issue of communication in which the findings of the Medical Officer is communicated to the candidate. The appeal should necessarily contain the following; (a) Review Medical Examination fee of Rs.25/-(Rupees twenty five) only <u>non refundable</u>, through a Bank Draft/ IPO in favour of "PAO, SSB (MHA), New Delhi", (b) Appeal Form 4, 5 & 6 issued by the Initial Medical Board declaring the candidate as Unfit, (c) One self addressed envelope with Rs.22/- postage stamp duly affixed on it. <u>Fitness certificate other than on Form – 6</u> (provided by the Chairman of Recruitment Board to the Candidates) submitted to appeal for Review Medical Examination will not be considered and rejected straightway.

The fitness certificate on Form- 6 is essential to consider their cases for review medical examination and not for any other purpose.

Path/ Lab test expenses if any, occurred during Review Medical Examination will be born by the candidates.
