- Minimum height 157 cms. Weight and Chest should be proportionate. Minimum Chest expansion of 5 cms.

- Sports Disciplines. Outstanding sportsmen who have participated at International/ > Candidates declared Medically Temporary Unfit in the recruitment medical examination can avail specialist review from the specified Military Hospital within a maximum period of 21 days. No further review/appeal is permissible.
 - Candidates declared Medically Permanent Unfit in the recruitment medicals can appeal for specialist opinion in a Military Hospital within 21 days on payment of Rs. 40 /- by Military Receivable Order (MRO) on Government Treasury.
