Applications are invited for one post of **Scientist - C** in the Pay Band-3 Rs. 15600-39100 +Rs.6600 (Grade Pay) + NPA in the Hqrs. Office upto 20.6.2011 under Health Research Scientist Cadre of ICMR Rules - 2007 and it carries All India transfer liability.

Essential Qualification:

- (i) MBBS Degree recognized by MCI.
- (ii) Four years R & D experience in the area of chronic diseases after obtaining essential qualification.

Desirable:

- (i) MD in PSM, Medicine, Pathology etc.
- (ii) Additional post doctoral research/teaching experience in chronic diseases in recognized institute(s).
- (iii) Knowledge of Computer Applications

Job Requirement:

To process and review project applications & reports; to prepare plan documents, to assist in developing project proposals, monitor and evaluate project activities, undertake data analysis & interpretation & prepare project reports. To assist the Head of Division in all activities including Parliamentary matters etc.

Note: MD Degree In Subjects Relevant to ICMR shall be treated equivalent to three years experience.

Age limit: Not exceeding 40 years as on 20.6.2011. Relaxable up to 5 years for Government servants in accordance with the instructions issued by the Department of Personnel and Training from time to time in this regard. The age relaxation is also allowed to SC/ST/OBC & PH candidates in accordance with the orders issued by the Central Government from time to time in this regard.

General Relaxation Clause: Age/Experience will be relaxable in cases of exceptionally meritorious candidates as mentioned in the recruitment rules of Health Research Scientists Cadre of ICMR, 2007.

Note: (i) SC/ST/PH candidates should submit attested copies of certificates for claiming fee concession/age relaxation.

(ii) OBC certificate for the purpose of age relaxation will mean "PERSONS OF OBC CATEGORY NOT BELONGING TO CREAMY LAYER" as defined in DOPT'S O.M. NO. 36012/22/93-Estt (SCT) dated 8.9.1993 and its subsequent revision through O.M. No. 36033/3/2004-Estt (Res) dated 9.3.2004 and 14.10.2008. The closing date for receipt of application will be treated as the date of reckoning for OBC status of the candidate and also for assuming that the candidate does not fall in the Creamy Layer on the reckoning date. The candidate should furnish the relevant OBC certificate in the format prescribed for Govt. Job and furnish declaration. OBC candidates must, therefore, furnish valid and updated OBC certificate which should specifically include the clause regarding "Exclusion from Creamy Layer" in order to get age relaxation.
