Note : Period of deputation/re-employment/short-term contract shall be for one year or till the life of the VWDT or till further orders whichever is earliest, but shall not ordinarily exceed for more than 3 years from the date of joining. The maximum age limit for appointment on deputation/short-term contract shall not be exceeding 56 years.
