The Business Policy Guidelines for Publications Division issued vide this Ministry's ID Note of even number dated 01.01.2019 has been reviewed in consultation with IFD and approval of the Competent Authority is hereby conveyed for amendments in the following clauses with immediate effect:

Clause 4(i)(a): Discount Structure for

Books for Agents:

The dispatch cost is for a single destination. For more than destination, the cost to be borne entirely by the Agent/ Distributor.

The dispatch will be allowed for multiple destinations also so that supplies can be sent to smaller cities; however, each supply shall not be less than 51 copies. For order/supply of 50 copies or less, the dispatch cost shall be borne by Agent / Distributor.

New sub-clause 6(e):

Return of Journals (including Employment News) to the extent of 5% of stock lifted by Agent/distributor will be allowed every three months to the agents/distributor on a single order of minimum 1001 copies of Journals or minimum 1001 copies of Employment News. The full copies need not be sent back but the "Masthead" showing the month of the publication of the journal/issue of Employment News will need to be sent.
